## Taux de transformation des saisines du CMAP

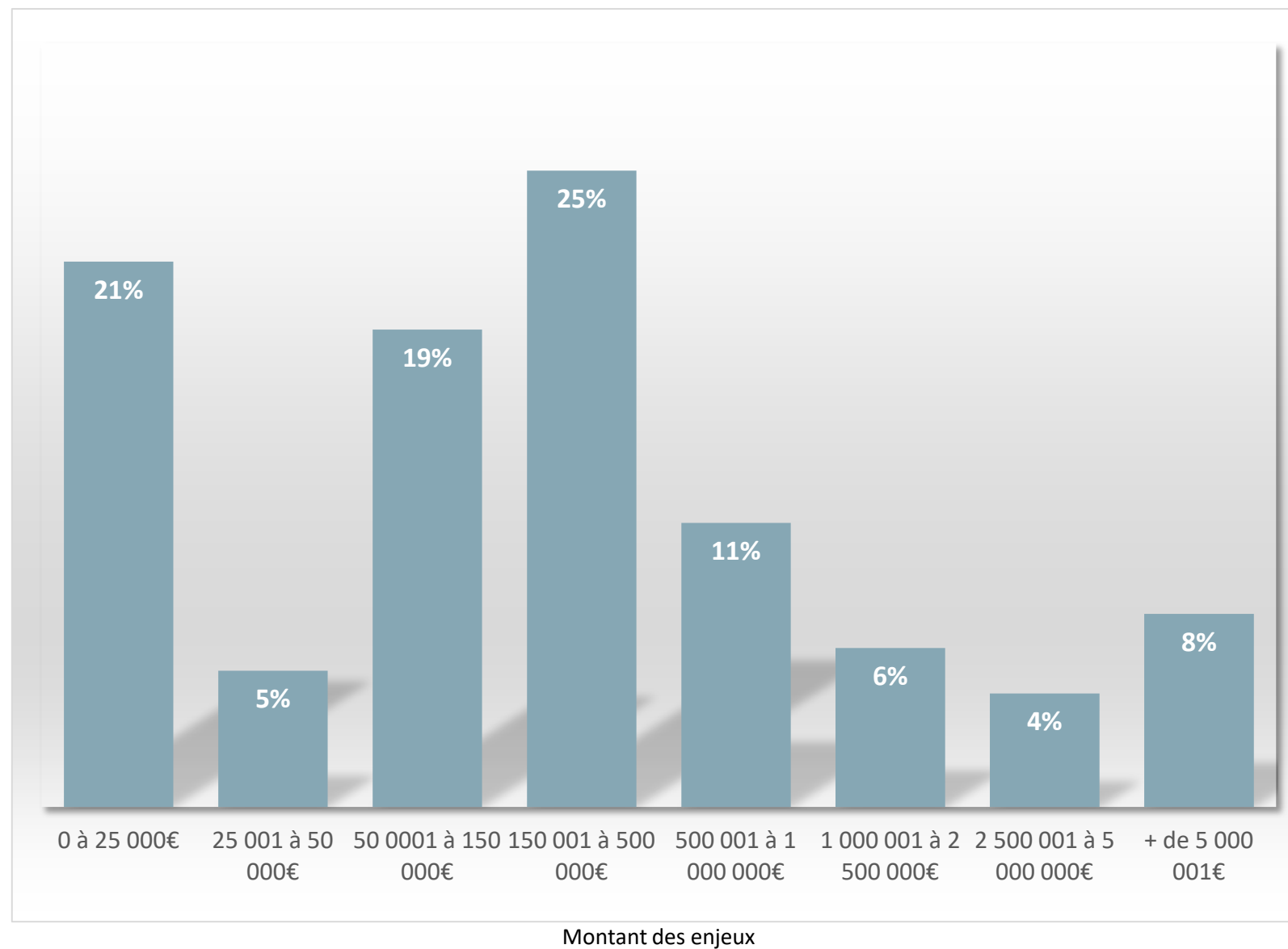

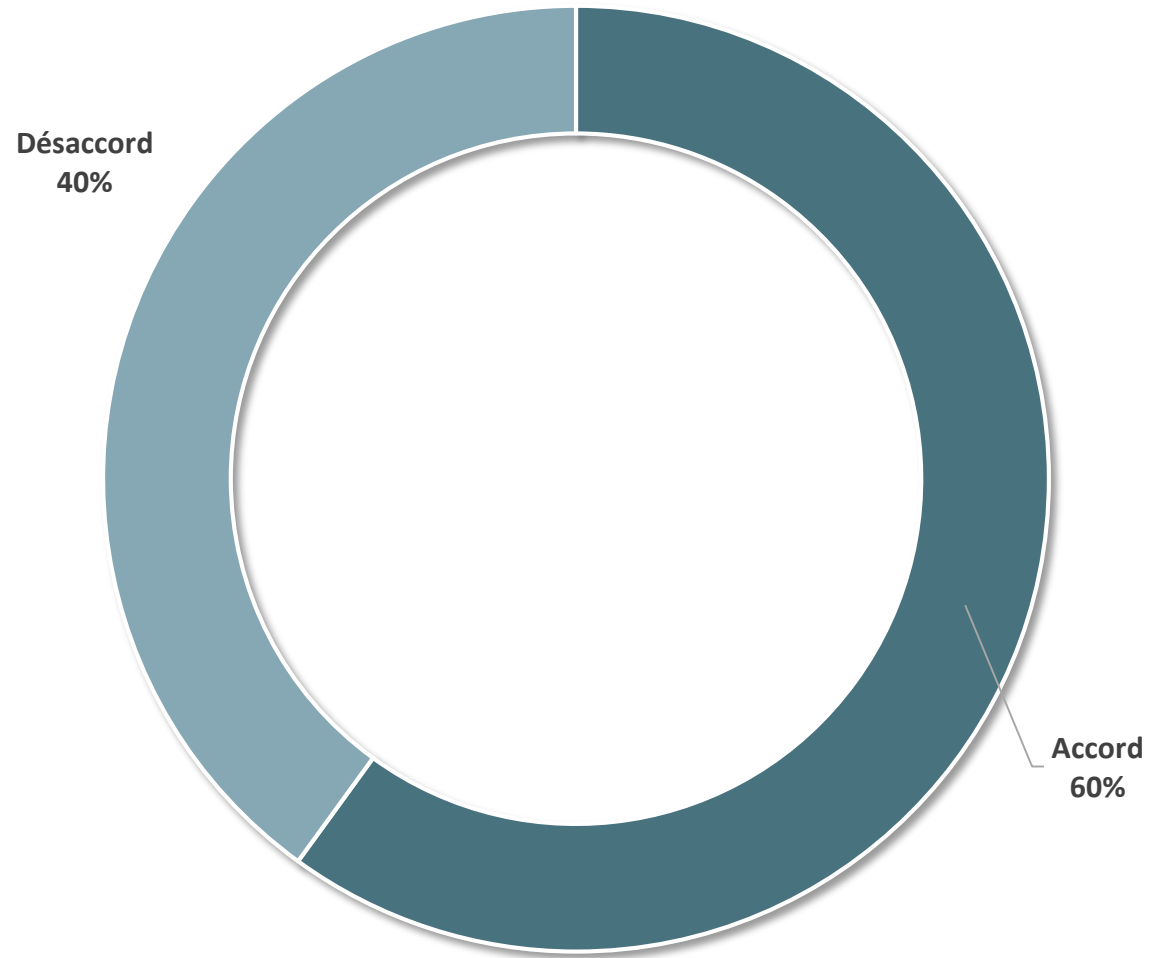
# COÛT TOTAL DE LA MÉDIATION



# COÛT MOYEN DE LA MÉDIATION PAR RAPPORT AUX ENJEUX EN LITIGE

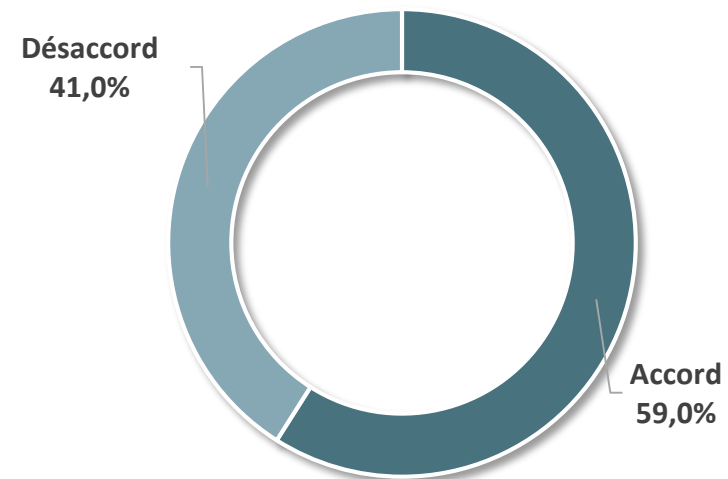
